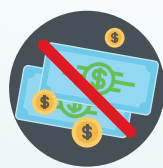

電子健康紀錄互通系統（醫健通）是一個全港性、以病人為本的電子平台，讓公私營界別獲授權的醫護提供者¹取覽和互通已參與病人的健康資料。

The Electronic Health Record Sharing System (eHealth) is a territory-wide and patient-oriented electronic platform. It enables access and sharing of participating patients' health data by authorised healthcare providers¹ in the public and private sectors.



參與醫健通後，醫院管理局（醫管局）、衛生署²，以及個別獲得你授權的私營醫護提供者也可閱覽及上載你的電子健康紀錄³，為你提供更適時的治療及診斷，並減少重複檢驗。

After joining eHealth, the Hospital Authority (HA), the Department of Health (DH)² and individual private healthcare providers authorised by you can access and upload your electronic health records (eHRs)³ for providing more timely treatment and diagnosis to you, and reduce repeated tests.

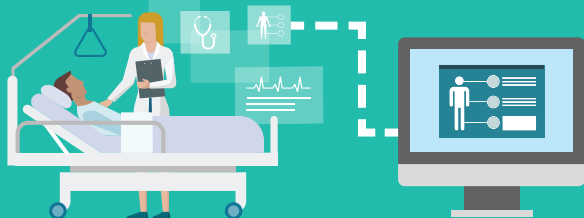

當我住院時，有關紀錄會上載至醫健通嗎？

Will relevant records be uploaded to eHealth during my hospitalisation?



有關的住院紀錄將於你出院時與相關醫療紀錄一併上載至醫健通，讓你的電子健康紀錄更全面、更準確！

Your relevant hospitalisation records, together with other related medical records, will be uploaded to eHealth after discharge, making your eHRs more comprehensive and accurate!

醫管局或衛生署的醫護專業人員會在什麼時候取覽我在醫健通內的紀錄？

When do healthcare professionals of HA and DH access my records via eHealth?



醫管局及衛生署的醫護專業人員會因應臨床需要（例如：個案分流、為將要被轉介入院的病人作準備、診症時及診症後的跟進等）取覽你於醫健通的電子健康紀錄。

Healthcare professionals of HA and DH may access your eHRs via eHealth based on clinical needs (e.g. triage, pre-admission care for referral cases, consultation, post-consultation follow-up etc.).
