

Previous diagnosis, medication, booked appointments and other health records¹ of elders can be shared in eHealth.



More comprehensive, timely and accurate eHRs can be accessed by authorised healthcare providers (HCPs)² for providing quality healthcare to elders.

如果長者無能力給予同意,誰可以為他/她申請?

If an Elder is Incapable of Giving Consent, Who can Apply for Him/ Her?

以下類別人士可以代決人身份為無能力給予同意的長者作出登記: The following types of person can register for an elder who is incapable of giving consent as his/ her eligible Substitute Decision Maker (SDM):

- (一) 根據《精神健康條例》(第136章)委任的監護人;
- (二) 社會福利署署長或根據《精神健康條例》委任為監護人的任何其他人⁵;
- (三) 獲法院委任以處理該長者事務的人士;
- (四) 如沒有(一)至(三)項所述的人士,則該長者的家人或與其同住的人士;
- (五)如沒有(一)至(四)項所述的人士,則正在或即將向該長者提供醫護服務的已參與 醫護提供者。
- (a) The elder's guardian appointed under Mental Health Ordinance (MHO) (Cap 136);
- (b) The Director of Social Welfare or any other person as guardian under MHO⁵;
- (c) A person appointed by court to manage the elder's affairs;
- (d) If there is no one in (a)-(c), the elder's family member or a person residing with him/her;
- (e) If there is no one in (a)-(d), a participating HCP who provides or is about to provide healthcare to the elder.
