

New Model of Radiology Exam & Images Sharing




Requirements for sharing Radiology Exam

Data Scope

- Similar data requirement
 - Patient Major Key, Report Date, Modality, Accession Number (Same format)
 - Extra fields required:
 - ✓ eHR number
 - ✓ Referring Number (for referral case)
 - **Reference:**
 - https://www.ehealth.gov.hk/filemanager/content/pdf/en/ehris/annex/Appendix_XV I_eHR_Radiology_Examination.pdf
- Welcome to upload the historical reports as much as possible for the consented patient (vs 2 years image)


Mind Map: Radiology Examination Report Dataset



CMS extension – Local adaptor adaptation module(LAAM)

- ✓ Developed by eHRSS
- ✓ Follow EHR standards
- ✓ Over 10 Healthcare Providers in-used
- ✓ Platform independent : Java-based Application Server with database (Windows, Mac, Linux)
- ✓ eHR license required
 - ➤ Interface specification can be obtained via eHRSS bulletin




Requirements for sharing Radiology Image

- DICOM conformance statements
 - DICOM Association
 - Supported SOP classes
 - Accepted Presentation Contexts
 - Supported Transfer Syntax
- Accession no.
 - Conform to standard format
 - Uniqueness within institution
 - Linked with RIS exam
- Radiology Exam record
 - RIS Exam record uploaded to EHR prior to radiology images
- Accept recent 2 year image studies


Image upload scenarios

- New image study
 - Images with new and unique study instance UID
- Override existing images
 - Images with the study instance UID of the images to be amended
 - Images in eHR will be overridden by the new study
- Delete existing images
 - IHE Imaging Object Change Management (IOCM) rejection note message that contains HCR's identity information and the study instance UID of the images to be deleted
 - Delete RIS exam record to withdraw report and images

Connectivity

- DICOM Connectivity
 - Pre-registered AE Title on eHR side
 - Register EHR DICOM gateway as new endpoint in HCP's DICOM gateway / PACS
- Network
 - Encrypted communication (IPsec VPN)
 - Support internet connection
 - Suggested network bandwidth: 50Mbps (upload) + 50Mbps (viewing)

Changeover approaches for image upload

- Parallel operation
 - short period of parallel run
 - then switch to eHR
- Direct cutover
 - HCP stops sending images to HA
 - HCP sends images to EHR
