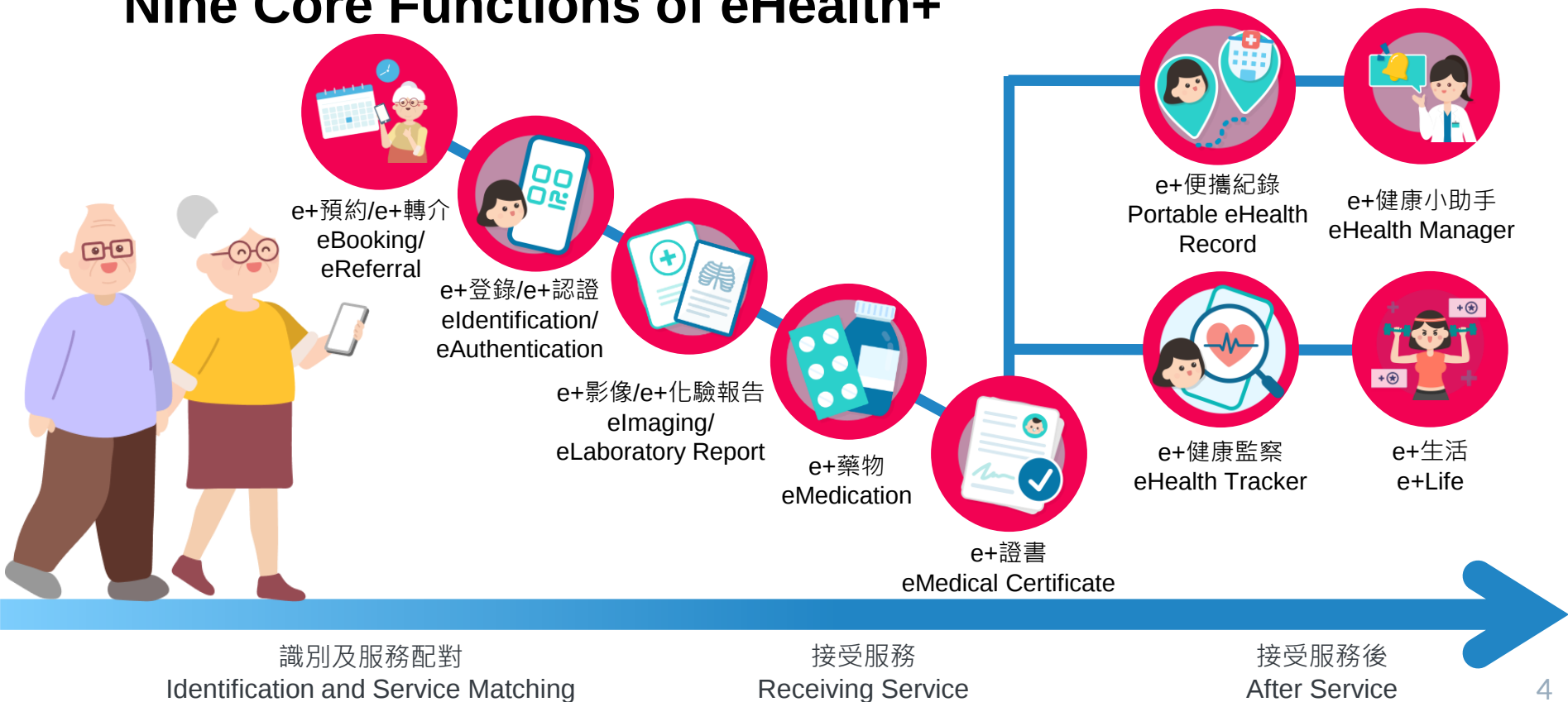

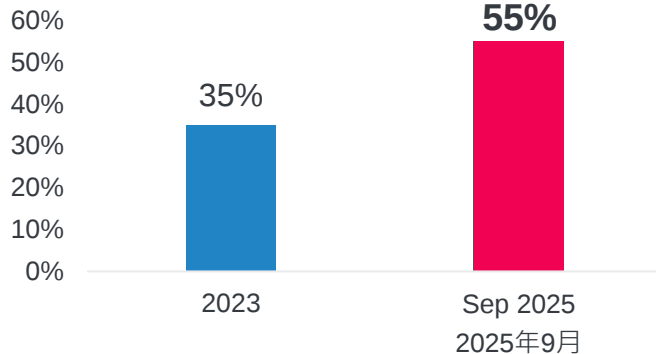

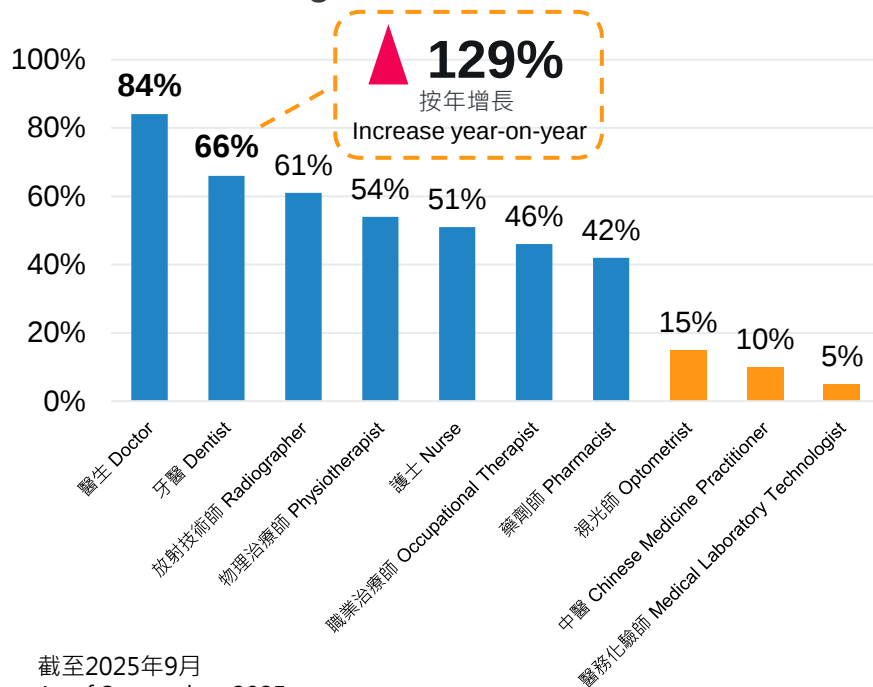

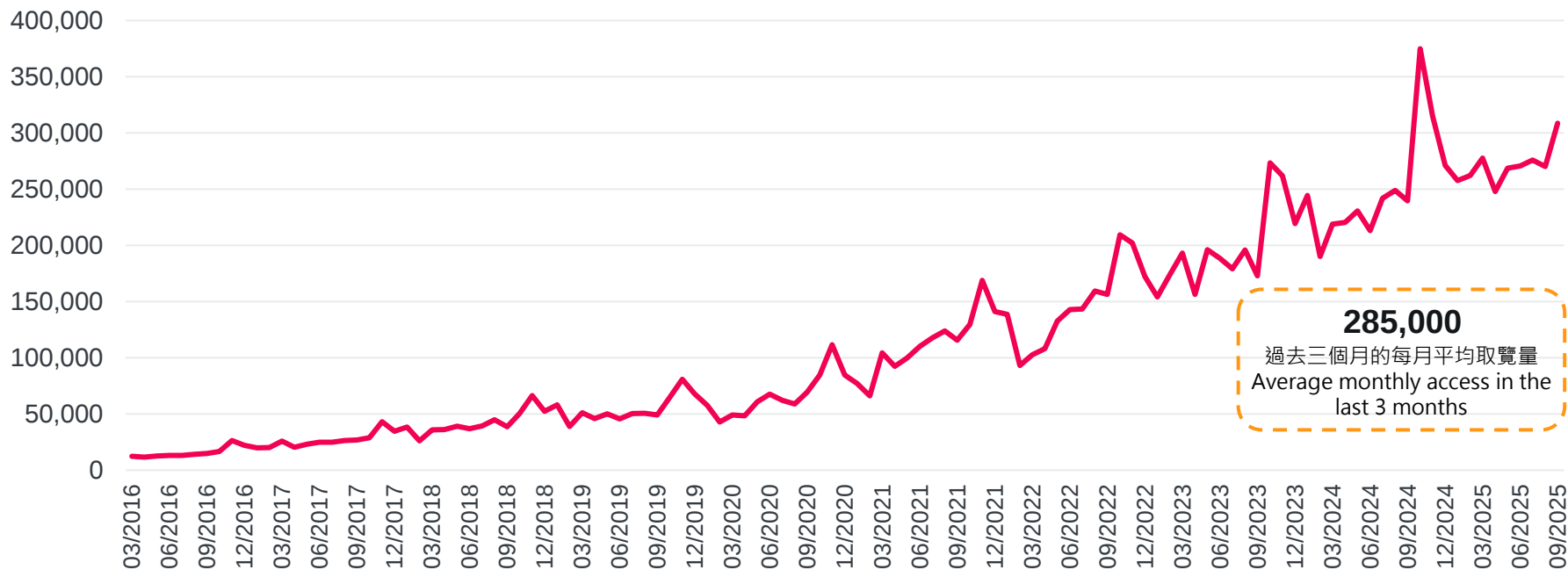

- ❑ 市民可申請過去三年的醫健通電子健康紀錄，於香港大學深圳醫院和「長者醫療券大灣區試點計劃」的19間醫療機構就診時讓相關醫護人員瀏覽
Citizens can apply for their eHRs in eHealth for the past three years and enable relevant HCProfs to access them during consultations in HKU-SZH and 19 medical institutions under the EHCV GBA Pilot Scheme
- ❑ 2025年12月將功能擴展至全港市民
To expand the function to all citizens in December 2025

南下: 個人資料夾

Southbound: Personal Folder



- ❑ 市民可將境外取得的醫療紀錄存放在其醫健通戶口
Citizens can deposit medical records obtained across the boundary into their personal eHealth account
- ❑ 2026年1月推出試點計劃，讓市民可以授權大灣區指定醫療機構將其放射影像及報告直接存入其「個人資料夾」
To launch a pilot scheme in January 2026 to enable citizens to authorise designated GBA institutions to deposit their radiology images and reports directly into their Personal Folder

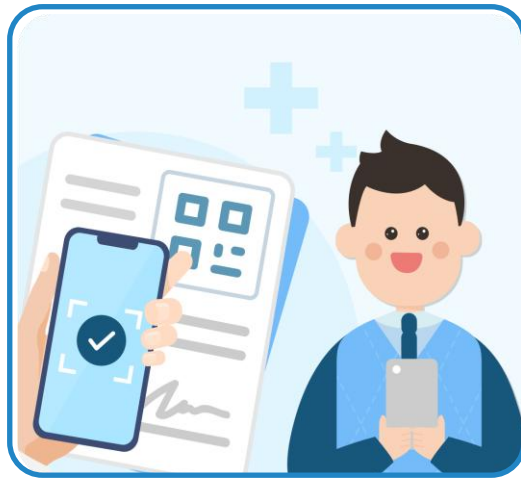

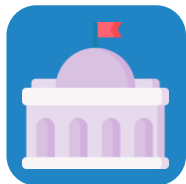

Enrich the centralised database to store different categories of health data of the Hong Kong population
- 構建醫健通大數據平台的基礎設施，包括建立具備人工智能和機器學習等功能的資料分析工具，支援數據分析及報告
Establish the infrastructure for eHealth big data platform, including building data analytics tools with AI and machine learning functions to support data analysis and reporting
- 我們會制定一個穩固的數據使用機制，在充分保障個人資料私隱及資訊安全的前提下，逐步開放醫健通數據作研究及統計用途
We will formulate a robust data usage mechanism and progressively open up eHealth data for research and statistics purposes, while ensuring stringent safeguards to protect personal data privacy and information security
